4. Rates quoted will be exclusive of all taxes. Please mention all relevant applicable

Tax/custom duties/ freight charges separately.

5. The management reserves the right to cancel the contract with 30 days' notice

Period without assigning any reason for cancellation.

6. The quantities indicated are approximate requirements and are subject to

Increase / decrease without notice and the Bidder will be bound to supply the

Increased / decreased requirements at the quoted rate.

7. Bidder shall supply the articles in such quantities as may be required from time

To time as per specifications laid down by the management. In case of failure to

Do so the management may be at its sole discretion purchase the items in respect

Of which the Bidder has defaulted, from the open market and debit the difference

Between the Bided rate and the open market rate, along with transport and other

Incidental charges if any, to the Bidder's account and adjust the same against the

Payment due to him from the management.

8. The Bidder shall not offer, pay, and promise to pay, or authorize the payment of any

Money, or offer, give, promise to give, or authorize the giving of anything of

Value, to any officer or employee of or any other person acting in an official

Capacity.

9. Payment Terms: 60 days from the date of receipt of the invoice.

10. The successful Bidder shall execute a separate formal agreement with each hotel

Mentioned in the Bid if so desired by the hotel. Such agreement shall be in the

Form acceptable to each individual hotel.

### **1 ANTI-BRIBERY AND ANTI-CORRUPTION**

1.2 The Supplier will not engage in any form of bribery or corruption (including

Making facilitation payments) when dealing with private parties, political

Parties or candidates or public officials.

1.3 The Supplier will not offer, provide, authorize, request or receive any financial

Or other advantage (e.g., gifts or hospitality) with the intent or prospect of

Influencing or determining the recipient's decision-making or other conduct

And/or as an inducement or reward for the improper performance of a person's

Relevant function.

1.4 If the Supplier becomes aware of any suspicious, risky, illegal or corrupt

Conduct or any conduct that violates this provision, it must be reported Immediately to Operator and the Supplier must follow the instructions of Operator in relation thereto.

1.5 Operator reserves the right to request, and the Supplier shall supply,

Supporting documentation and back-up relating to the goods and Services

Supplied under this Agreement to audit the Supplier's compliance with this

Clause. In addition, Operator reserves the right to request the Supplier,  
at any

Time, to provide a compliance certificate certifying the Supplier's  
compliance

With this clause.

1.6 The Supplier hereby indemnifies and holds harmless, irrevocably  
and in

Perpetuity, Operator and its affiliates from any and all claims of  
whatsoever

Nature made by any third party arising, whether directly or indirectly,  
as a

Result of a breach by the Supplier of any one or more of the  
undertakings set

Out in this clause.
