UBF is granted legal personality No:25/RGB/FDN/LP/06/2023 as registered under the Rwanda Governance Board to operate its activities in Rwanda since 29th June 2023.

To be operational in Rwanda, the license from the regulator BNR (National Bank of Rwanda) has been acquired on 30th October 2023 under the **BNR Insurance License** N°: I 01/20232.
