7. Bids will be opened with bidders' representatives who choose to attend on **21/03/2025 at 10:15 p.m. local time** in the Board Room of UDL's head office, located at RSSB Twin Towers – Tower II. Bids shall remain valid for **120 days** after the deadline for Bid Submission.
8. UDL shall award the supply contract to the Bidder whose offer will have been determined to be the lowest evaluated bid and substantially responsive to the Tender Document, provided further that the Bidder is determined to be qualified to perform the Contract satisfactorily.
